Supervisor Murray led in the Pledge to the Flag.

She asked if there were any additions or corrections to the minutes of the July meeting. There were none. Mr. Elsworth made a motion to accept the minutes as sent. Mr. Manwarren seconded the motion. The Board was polled and the motion was carried with four yeses and one abstention. Ms. Fairbanks abstained from the vote because she had been absent at the July meeting.

DOG CONTROLL OFFICER'S REPORT: Mr. Brian Franklin gave his report which is on file in the Town Clerk's office.

HIGHWAY SUPERINTENDENT'S REPORT: Mr. Louis Redenback gave his report which is on file in the Town Clerk's office.

After Mr. Redenback presented the Board with three quotes for the up fitting on the new truck, Mr. Manwarren made a motion to use Palmer's at a cost of \$57,235.00. Ms. Fairbanks seconded the motion. The Board was polled and the motion was passed with five yeses and no nos.

Ms. Fairbanks made a motion to transfer \$52,855.50 from DA2680 (insurance recovery) toward the cost of the new truck. Mr. Elsworth seconded the motion. The Board was polled and the motion was passed with four yeses and one no. Mr. Wightman voted no.

Mr. Manwarren made a motion to transfer \$4,379.50 from DA5120.4 for the balance of the cost of the new truck. Ms. Fairbanks seconded the motion. The Board was polled and the motion was carried with four yeses and one no. Mr. Wightman voted no.

Mr. Wightman read Resolution #22 Resolution to Accept the Proposed Budget Amendment. Mr. Manwarren moved to accept the Resolution. Mr. Elsworth seconded the motion. The Board was polled and the Resolution was passed with four yeses and one no. Mr. Wightman voted no.

Mr. Manwarren read Resolution #23 Prohibiting Personal Vehicles and Equipment in the Town Highway Garage. He so moved. Ms. Fairbanks seconded the Resolution. The Board was polled and the Resolution was passed with five yeses and no nos.

YOUTH COMMITTEE: Mrs. Shelly Ciborowski gave her report which can be found on file in the Town Clerk's office.

Ms. Murray revealed that she had voted no on the Chenango County proposal to spend \$60,000,000.00 to build a new County Office Building.

The bills were reviewed and signed. Mr. Manwarren made a motion to pay the bills. Ms. Fairbanks seconded the motion. The Board was polled and the motion was carried with five yeses and no nos.

Ms. Fairbanks made a motion to adjourn the meeting. Mr. Manwarren seconded the motion. The Board was polled and the motion was carried with five yeses and no nos. The meeting was adjourned at 8:56pm.
