Supervisor Tim Manwarren brought the meeting to order and led in the Pledge to the Flag.

HIGHWAY SUPERINTENDENT'S REPORT: Louis Redenbach reported that they have been plowing and sanding a lot in the last month. He started getting sand from tri-city out of Brisben. It is manufactured sand so it has been through the wash plant. We should have less issues of mud on the roads. It is a trial thing right now to see how it works. So far we are very happy with it. We now have truck # 4 back from the shop, it needed a new clutch and fly-wheel. We also have truck #1 back from getting exhaust leak fixed. We picked up the New F550 and dropped it off at Palmers to have equipment installed. We have switched to using waste oil only in the shop as Tim Manwarren found a good source for the oil. It stays warmer and uses less fuel while on waste oil.

PLANNING BOARD MEETING REPORT: A quorum was present.

Presented and read by John Owens. Kathy Clemens had spent time with the assistance of Chenango county Planner Matt Gladstone working on creating a digital survey. It is in good shape. A few suggestions were made for minor modifications and we think a final draft should be available soon.

He was also requested to consider allowing the Planning Board have a Public Hearing prior to an upcoming Town Board Meeting to make the public aware of the survey.
